Re: Pennsylvania Electric Company Tariff Electric Pa. P.U.C. No. 81, Tariff Electric Pa. P.U.C. No. S-1 and Third Party Data Access Tariff Electric Pa P.U.C. No. TP-1, Changes in Compliance with Pennsylvania Electric Company's Default Service Plan

Dear Ms. Savage:

By Order entered August 4, 2022, the Commission authorized Pennsylvania Electric Company (Penelec or the Company) to file a tariff supplement as set forth in the Joint Petition for Partial Settlement filed in the above docketed default service proceeding. On March 31, 2023, the Company filed Supplement No. 144 to Tariff Electric Pa. P.U.C. No. 81, Supplement No. 11 to Tariff Electric Pa. P.U.C. No. S-1, and the Third Party Data Access Tariff Electric Pa P.U.C. No. TP-1, all to become effective June 1, 2023, in compliance with the Order. Supplement No. 144 to Tariff Electric Pa. P.U.C. No. 81 and Supplement No. 11 to Tariff Electric Pa. P.U.C. No. S-1 reflect changes in language consistent with the Order which approved Penelec's Default Service Program for the period June 1, 2023 - May 31, 2027. Original Third Party Data Access Tariff Electric Pa P.U.C. No. TP-1 establishes new rules and regulations applicable to all Third Parties seeking to obtain customer data pertaining to customers located in the Company's service territory, in compliance with the Order.

Commission Staff has reviewed the tariff revisions and found that suspension or further investigation does not appear warranted at this time. Therefore, in accordance with 52 Pa. Code Chapter 53, Supplement No. 144 to Tariff Electric Pa. P.U.C. No. 81, Supplement No. 11 to Tariff Electric Pa. P.U.C. No. S-1, and the Third Party Data Access Tariff Electric Pa P.U.C. No. TP-1 are effective by operation of law as of the effective date contained on each page of the filings. However, this is without prejudice to any formal complaints timely filed against said tariff revisions.
