Companies that did not file an annual revenue report or
pay past due assessments and fees

FINAL ORDER

On March 2, 2023, a Tentative Order was entered in the above captioned proceeding.

Both the Code, 66 Pa. C.S. § 2208(c)(2), and Commission regulations, 52 Pa. Code § 62.113(a)(5), state that the failure of an NGS to comply with applicable provisions of the Code or the rules, regulations, orders, or directives of the Commission shall be cause for the Commission to revoke the license of the NGS.

Assessments and Fees

The Natural Gas Suppliers (NGS) listed in Table 1 below paid the past due assessment and fee balance within 30 days after publication in the *Pennsylvania Bulletin*.

Disposition

The Natural Gas Supplier Licenses held by the companies listed in the Table 3 - Supplier Cancellation are cancelled and shall be stricken from all active utility lists maintained by the Commission's Bureau of Technical Utility Services and the Assessment Section of the Bureau of Administration, removed from the Commission's website, and notifications be sent to all natural gas distribution companies in which the Natural Gas Suppliers are licensed to do business.

The remaining NGS licensee, on the March 2, 2023, NGS Cancellation Tentative Order, FINANCE GURU LLC, at Docket No. A-2019-3012217, filed an application to abandon its NGS license as a supplier in Pennsylvania on March 8, 2023. The Commission's regulations at 52 Pa. Code §62.112(b) require that a licensee may not abandon service without providing 90 days prior written notice to the Commission, the licensee's customers, the affected distribution utilities, and suppliers of last resort prior to the abandonment of service.

The Tentative Order has become FINAL by operation of law. FINANCE GURU LLC may be granted a NGS license abandonment, once the licensee provides all required documentation and assures the Commission that all obligations to Pennsylvania customers and the Commonwealth have been met.
