Pursuant to the Pennsylvania Public Utility Commission’s (“PUC”), Rules of Administrative Practice and Procedure and the PUC’s June 18, 2020 Phase IV Final Implementation Order¹, providing for PPL Electric Utilities Corporation’s (“PPL”) Act 129 Phase IV Energy Efficiency and Conservation Plan (“EEC Plan”), The Sustainable Energy Fund of Central Eastern Pennsylvania (“SEF”), submits its Verified Comments in Support of PPL’s request for approval of one Major Change to its EEC Plan.

PPL proposed Major Change is to shift approximately \$6 million from the Large C&I Sector’s Reserve Incentive Budget in the Non-Residential Program to the Small C&I Sector’s Reserve Incentive Budget in the Non-Residential Program with no changes to projected participation, energy savings, or peak demand reductions.

SEF believes that this Major Change is reasonable and reflects actual participation in the Phase IV programs without changing the total cost of the EEC Plan.
