Dear Secretary Chiavetta:

On February 8, 2024, PPL Electric Utilities Corporation (“PPL Electric”) filed a Petition for Approval of a Change to its Act 129 IV Energy Efficiency and Conservation (“EE&C”) Plan with the Pennsylvania Public Utility Commission (“Commission”).

In its Petition, PPL Electric proposed to shift approximately \$6 Million from the Large Commercial and Industrial (“C&I”) sector’s reserve incentive budget in the non-residential program to the Small C&I sector’s reserve incentive budget in the non-residential program.

In addition, the Petition proposed to make no changes to projected participation, energy savings, or peak demand reductions.

The Office of Small Business Advocate (“OSBA”) has reviewed the Petition, and has discussed the details of the Petition with PPL Electric. The OSBA supports the changes proposed by the Petition, and respectfully submits that the proposed changes are just and reasonable.
