Energo Power & Gas LLC (Energo) has entered into an Asset Purchase Agreement to transfer Energo's active natural gas accounts to Sprague Operating Resources, LLC (Sprague). Actual transfer of the accounts will not occur until a later date once the transaction closes, which is conditioned on the completion of several items. In the meantime, Energo is sending assignment notices to certain limited customers that must provide consent before their accounts can be transferred. For Energo's remaining natural gas customers, Energo will provide additional notice prior to the transfer of those accounts to Sprague.


