CUSTOMER ASSISTANCE PROGRAM (CAP)

- PROVIDES AFFORDABLE MONTHLY PAYMENTS BASED ON HOUSEHOLD SIZE AND MONTHLY GROSS INCOME
- CUSTOMERS WITH PRE-PROGRAM BALANCES RECEIVE ARREARAGE FORGIVENESS
- CUSTOMERS RECEIVE MONTHLY CAP CREDIT'S WHEN THE USAGE BILL IS HIGHER THAN THE CAP PAYMENT
- INCOME GUIDELINE UP TO 200% OF THE FEDERAL POVERTY LEVEL
- CAP CUSTOMERS ARE EXEMPT FROM LATE PAYMENT FEES AND SECURITY DEPOSITS
- ADMINISTERED BY DOLLAR ENERGY FUND.-PEOPLES CSC REPS SCREEN AND REFER CUSTOMERS TO DEF TO APPLY OR RECERTIFY

RECENT CHANGES MADE TO CAP

- Percentage of income amounts that customers pay were lowered from 8, 9, and 10% to 4, 5, and 6% in order to reduce the energy burden on limited income CAP eligible customers.
- Recertification periods were extended from 1 year to 2 years for customers with employment income and from 2 years to 3 years for fixed income types of Social Security, SSI and Pension.

RECENT CHANGES MADE TO CAP Cont.

- Implementation of a paper application.
- Identification of CAP customers who move to a new address for review and expedited enrollment at the new address.
- CAP customers who apply for a DEF grant are only required to make 2 CAP payments instead of 3 to meet the GFP requirement.

BUDGET BILLING

- GAS CONSUMPTION IS AVERAGED OVER A 12 MONTH PERIOD AND CALCULATED BY COMPARING PAST USAGE FOR THE HOME WITH PROJECTED WEATHER CONDITIONS AND RATES
- PROVIDES MORE CONSISTENT MONTHLY BILLS
- THE BUDGET PAYMENT IS REVIEWED QUARTERLY AND ADJUSTED IF NECESSARY
