"Information for Shippers" as required by 52 Pa. Code §31.121(a) of which the bottom part has to include the name of the shipper, the date certified that the information for shipper was furnished to this person and the signature of the carrier representative. The carrier shall retain a copy of this certification with the shipping order.

Continued operations, as described above, may subject you to penalties which may include the assessment of fines up to \$1,000 per violation.




