This will acknowledge receipt of your 1984 Annual Report which was not timely filed in accordance with Pa. Code, Title 52 §31.9 (f). This section states in part that unless an extension has been granted by the Commission, each Annual Report should be filed not later than March 31 of the ensuing year and further imposes a minimum penalty of \$50 during the first thirty (30) days of such delinquency, and an additional minimum penalty of \$50 for each additional 30-day period or fraction thereof that the delinquency continues.

A fine of \$100 is now pending for the late filing of your Annual Report. Prompt payment of this \$100 fine will preclude the Commission from issuing a complaint for the non-payment of said \$100 fine. A check for \$100, should be made payable to the Pa. P.U.C. and sent to the above address and in care of Mr. Joseph T. McDevitt, Chief, Financial Document Section.

Failure to pay said fine may lead to the cancellation of all rights, powers and privileges as granted by the Commission.

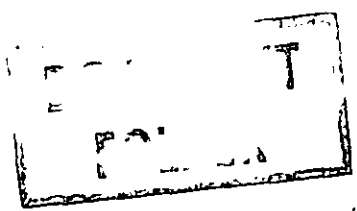

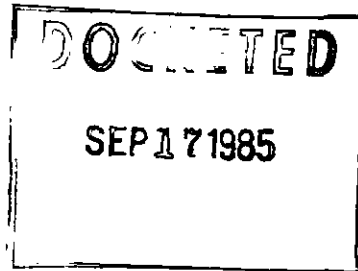
