Please use this letter as our affidavit in which we refer to Title 52, Section 23.67 Financial Data which provides that no justification will be required in support of a proposed increase in rates if the projected increased income does not exceed one (1) percent of the Pennsylvania gross revenues. Listed herein are the figures that will show the qualification.

Your applicant is seeking a 4.0% increase in hourly rates for Schuylkill County. In 2012, our company generated a total of \$76,280 in local moving revenue. Applying the 4.0% x \$76,280 generates \$3,051 of new revenue.

Your applicant is seeking a 4.1% increase in hourly rates for Columbia County. In 2012, our company generated a total of \$34,820 in local revenue. Applying the 4.1% x \$34,820 generates \$1,428 of new revenue.

Your applicant is seeking a 4.1% increase in hourly rates for Carbon County. In 2012, our company generated a total of \$20,320 in local moving revenue. Applying the 4.1% x \$20,320 generates \$833 of new revenue.

Your applicant is seeking a 4.1% increase in hourly rates for Luzerne County. In 2012, our company generated a total of \$24,010 in local moving revenue. Applying the 4.1% x \$24,010 generates \$984 in new revenue.

Your applicant is seeking a 3.4% increase in hourly rates for Lancaster County. In 2012, our company generated a total of \$70,070 in local moving revenue. Applying the 3.4% x \$70,070 generates \$2,382 of new revenue.

Your applicant is seeking a 3.4% increase in hourly rates for Lebanon County. In 2012, our company generated a total of \$18,240 in local moving revenue. Applying the 3.4% x \$18,240 generates \$620 of new revenue.

Totaling the new income should the proposed increase be approved as follows results in \$9,298. For calendar year 2012 your applicant generated total PA income of \$3,294,083.

Applying under PA Code, Title 52, Section 23.67 and applying 1% of \$3,294,083 results a total of \$32,941 compared to the projected revenues of \$9,298. We trust this information will be helpful in support of our contention that no further justification data will be required in the processing of our very minimal increase in hourly rates.
