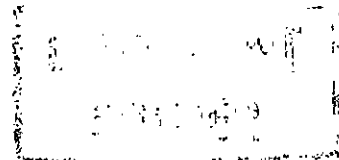
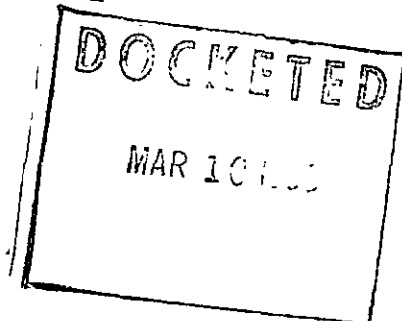
The above application has been protested by various carriers, and we are unable to reach an agreement as to a satisfactory restrictive amendment.

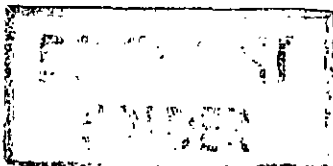
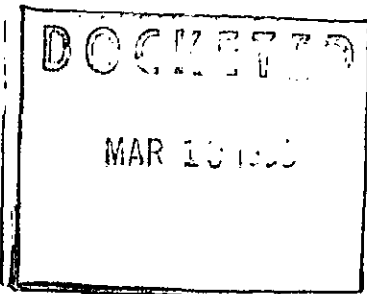
