(a) TRISTATE HOUSEHOLD GOODS CONFERENCE, INC.,
 MEMBERS IN BLAIR COUNTY
 INCREASE IN RATES

(b) Tristate Household Goods Tariff Conference, Inc. (Tristate) has filed 11th Revised Page 53 to Tariff Freight Pa. PUC No. 50 on June 30, 2006 and proposes a total increase in revenues of \$33,916 to cover increased wage and fringe benefits for carriers in Blair County. The current rates have been in effect since August 12, 2002. Tristate proposes to increase the hourly 3 men and vehicle normal complement charge by 9.1%. The current hourly rate for Blair County is \$99 per hour. Tristate proposes increasing this rate to \$108 per hour. Ernest L. Dinges, t/a Dinges Moving & Storage Co., Gearharts Moving & Storage, Inc., and Park Transfer & Storage Co., Inc. are the affected carriers. Tristate has submitted documentation supporting the proposed increase indicating that it is necessary to cover the cost of operating. Employee wages and fringe benefits have increased by 24% from \$16.57 per hour in 2002 to \$20.55 per hour in 2006.

(c) The data compiled and submitted by the carriers support this increase and the Bureau recommends that 11th Revised Page 53 to Tariff Freight Pa. PUC No. 50 be approved to become effective September 18, 2006.
