



Dear Mr. Bingaman:

Our company is seeking an hourly rates increase on shipments transported distances of forty (40) miles and less.

In accordance with 52 Pa. Code 23.67 Financial Data I have attached a document that reflects the provisions of this section. Our 2013 Pennsylvania Gross Revenues amounted to \$4,132,202. Applying the one (1) percent times that amount is \$41,322. Our 2013 household goods in use under 40 mile revenues amounted to \$418,004. Applying the 9% increase times that amount is \$37,620 which meets the criteria of this section.
