
**SUPPLEMENTAL ORDER CANCELING

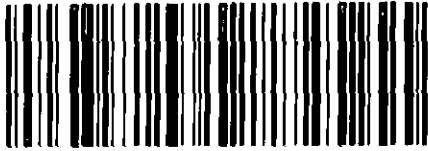

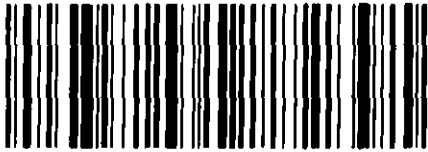
