Pursuant to the Commission's May 7, 2004, Final Rulemaking Order amending Electric Service Reliability Regulations (52 Pa. Code §§57.191 - 57.197) at Docket Nos. L-00030161 and M-00991220, UGI Utilities, Inc. - Electric Division ("UGI") hereby files its Quarterly System Reliability Report. This report contains SAIDI, SAIFI, and CAIDI results on a 12-month rolling basis for the period ending March 31, 2015, along with the raw data from the same period. Also included is a breakdown of outages by cause for the 12 months ending March 31, 2015. The actual statistics are favorable to both the benchmark and standard adopted for UGI.

#### **SAIDI**

The SAIDI value for the 12 months ending March 2015 is 59. This result is 6% lower than results reported through December 2014.

#### **SAIFI**

The 12-month rolling SAIFI index decreased 14% from 0.44 in our last quarterly report to 0.38 for the period ending March 2015.

#### **CAIDI**

The CAIDI result of 153 for the 12-month reporting period ending March 2015 is up 6% from our last report.

All index values fall below their respective standard and benchmark levels. UGI believes the changes in reliability results compared with the previous reporting periods are due to the natural variation of the events in each period and do not indicate any trends. It is always important to note, however, that weather conditions can have considerable impact on these values.
