

**NOTE 1 - MINIMUM TRANSPORTATION CHARGES:** Sundays and Holidays: 8 hours at rates named in Columns 1 and 2.  
Weekdays, 6:01 PM to 6:00 AM and Saturdays (any hour): 4 hours of rates named in Columns 1 and 4.  
Weekdays, 6:01 AM to 6:00 PM: 4 hours at rates named in Columns 1 and 3.

**NOTE 2 -** When a Holiday falls on a Saturday, rates named in Columns 1 and 2 shall be applicable.

**NOTE 3 -** Rates named in Columns 3 and 4 apply only from 6:01 AM to midnight on any day when a higher rate is shown for the following day.

**NOTE AA -** A flat charge based on one-half (1/2) hour when distance from original point of origin to final destination is 10 miles or less. One (1) hour when distance from original point of origin to final destination is more than 10 miles but not exceeding 25 miles. One and one half (1 1/2) hours when distance from original point of origin to final destination is more than 25 miles but not exceeding 40 miles.
