Dear Secretary Chiavetta:

On April 20, 2020, Duquesne Light Company (“Duquesne Light” or the “Company”), filed the *Petition of Duquesne Light Company For Approval of Default Service Plan For The Period June 1, 2021 Through May 31, 2025* (“Petition”) at the above-captioned docket, and provided service via electronic mail as indicated on the Certificate of Service attached thereto.

On April 27, 2020, Duquesne Light Company filed a Supplemental Certificate of Service updating contact email addresses for four entities identified in the initial Certificate of Service. The Pennsylvania Public Utility Commission subsequently notified the Company that its emails to certain other entities identified on the original Certificate of Service – namely, AP Gas & Electric and Just Energy Pennsylvania Corporation – were returned as undeliverable.¹ Though the Company’s initial emails AP Gas & Electric and Just Energy were not returned, out of an abundance of caution, the Company has identified alternative contact email addresses for these entities, and is serving them as indicated on the attached Second Supplemental Certificate of Service.

¹ Emails to Mint Energy, LLC were also returned as undeliverable. The Company has determined that Mint Energy, LLC is no longer active in the Company’s service territory, and appears to no longer hold an Electric Generation Supplier license from the Commission. Mint Energy, LLC is therefore omitted from the Second Supplemental Certificate of Service.
