In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Subject to Notes 1 to 18 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

- ▲ NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).
- ▲ NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days, or period of days, as indicated, during which services are performed.
- ▲ NOTE 3 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.
- ▲ NOTE 4 - Where "WEEKDAYS" services commence at the request of the shipper after 5:00PM and before 6:00AM, rates in Column 4 shall apply.
- ▲ NOTE 5 - Waiver of Saturday (Column 4) rates for carrier convenience: Carrier shall not assess Saturday (Column 4) rates for a Saturday move when said move is performed solely at the carrier's convenience. In such case, the carrier shall charge based on Weekdays (Column 2) rates.
- ▲ NOTE 6 - Supervisor hourly rate, when applicable, will be charged at a rate \$5.00 above the driver hourly rate.
- ◆ NOTE 7 - Add "vehicle" rate shown in this note to "driver" rate shown above:

Straight Truck - \$30.00 per hour
Tractor & Semi-Trailer - \$50.00 per hour
- ▲ NOTE 8 - Hourly rates (Columns 2, 3 and 4) computed in quarter hour periods; fractions of one-quarter hour considered as one-quarter hour.
- ▲ NOTE 9 - Applicable travel charge will be determined based on distance from carrier's terminal to either the first point of origin or final destination back to carrier's terminal, whichever is furthest:

Over 0 miles but not over 15 miles - One (1) hour

Over 15 miles but not 25 miles - One and one-half (1 1/2) hours

Over 25 miles but not over 30 miles - Two (2) hours

Over 30 miles but not over 40 miles - Two and one-half (2 1/2) hours

Over 40 miles but not over 50 miles - Three (3) hours
- ▲ NOTE 10 - Minimum Transportation Charges:
 Weekdays: three (3) hours at rates named in Column 2 plus applicable travel charge.
 Sundays and Holidays: six (6) hours at rates named in Column 3 plus applicable travel charge.
 Saturdays: four (4) hours at rates named in Column 4 plus applicable travel charge.

▲ NOTE 11 - Waiver of minimum charges for carrier convenience: Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time to complete the move plus applicable travel charge.

▲ NOTE 12 - When storage-in-transit shipment is not unloaded at carrier's warehouse and shipment remains on carrier's vehicle, an overnight SIT flat charge of \$250.00 per vehicle per night will be assessed. Traveling time on delivery will be added using the distances in Column 1 (see Note 9). The prevailing minimum charge will apply on each day of service.

▲ NOTE 13 - In lieu of applicable rate provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier for Packing, Unpacking and Containers charges, apply a \$35.00 hourly charge per packer plus applicable Container Charge (Item 310). This charge will apply when either packing or unpacking services only are requested.

The following notes apply in lieu of rates and rules & regulation provided in Tariff Freight Pa. P.U.C. No. 50 (50-T for moves 40 miles and less) and Tariff Freight Pa. P.U.C. No. 51 (51-W for moves in excess of 40 miles).

▲ NOTE 14 - Depreciated Value Protection will not be offered.

NOTE 15 - In lieu of the applicable rates provided in Tariffs Freight Pa. P.U.C. Nos. 50 & 51 for the above carrier, the cost to Supply, Pack and Unpack TV Cartons is: Supply/Pack - \$150.00 each and Unpack - \$25.00 each.

▲ NOTE 16 - In lieu of applicable rates provided for in Tariffs Freight Pa. P.U.C. Nos. 50 & 51 for the above carrier the cost to Supply/Pack Mattress Bags is: \$15.00 each.

▲ NOTE 17 - A pre-paid deposit of \$200.00 is required at the time the move is scheduled. Cancellation Policy: 50% of the deposit fee will be refunded if move is cancelled 8-14 days prior to the move date. No refund of the deposit fee if move is cancelled 0-7 days prior to the move date.

▲ NOTE 18 - Pickup or delivery on SIT - Schedule I
