Attached are updates for 350<sup>th</sup> Page 2, 202<sup>nd</sup> Revised Page 2-A, and 12<sup>th</sup> Revised Page 44 for George Transportation Company, The Snyder Brother Moving, Inc., t/d/b/a (PA PUC #A-00086452) in Freedom PA. This filing is for an INCREASE in their local hourly rates Monday to Friday and Saturday, a DECREASE in local hourly rates on Sundays & Holidays, a CHANGE in verbiage regarding minimum transportation rates and travel time charge for over 40 miles, and an INCREASE for Item 200 and Section 3 rates in lieu of rates in Tristate 51-W. Verbiage was CHANGED to show that rates apply to shipments traveling between point in Pennsylvania as George Transportation Company – The Snyder Brother Moving, Inc, t/d/b/a was “grandfathered” for statewide operating authority in May 2015. **Please REMOVE the following pages: 9<sup>th</sup> Revised Page 44-A, 7<sup>th</sup> Revised Page 44-B, and 5<sup>th</sup> Revised Page 45 as these pages are no longer applicable.** The Issue Date for this revision is January 14<sup>th</sup>, 2021, with an Effective Date for these exceptions in Tariff 54 of March 1<sup>st</sup>, 2021. NOTE 1 - When a holiday falls on a Saturday, the rates named in Columns 3 will apply.

▲ NOTE 2 - 8 hours minimum transportation charges plus applicable travel time charges for Sundays and Holidays.

▲ NOTE 3 - 5 hours minimum transportation charges plus applicable travel time charges for Monday-Saturday.

NOTE 4 - If services requested by shipper after 5:30PM, Monday-Friday, rates shall be on a time and one-half basis in Column 2.

NOTE 5 - When distance from carrier's terminal to point of origin and from destination back to carrier's terminal is:

- ( a ) 0 - 15 miles, one hour travel at the applicable rates.
- ( b ) 15 - 24 miles, one and one-half hours travel at the applicable rates.
- ( c ) 25 - 40 miles, two hours travel at the applicable rates.

▲ ( d ) When distance exceeds 40 miles, a one-half hour travel charge will apply for each additional 15 miles.

NOTE 6 - Depreciated Value Protection will not be offered.

NOTE 7 - Item 301 (Pack & Unpack) - Apply Schedule F.
