

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays (any hour): eight (8) hours at rates named in Columns 1 and 2. Holidays (any hour): eight (8) hours at rates named in Columns 1 and 5.

NOTE 2 - A flat charge based on one hour at the applicable transportation rates shown in Columns 2, 3, 4 or 5 will be assessed to cover traveling charges to and from the job when the combined distance from carrier's terminal to first point of origin and from final destination back to carrier's terminal is 30 miles or less. When the combined distance is 30 to 50 miles, a charge of 1 1/2 hours is applicable and, when the combined distance exceeds 50 miles, an additional charge based on 1/2 hour for each additional 20 miles will apply.

NOTE 3 - Rates named in Columns 2, 3, 4 and 5 apply only to 12:00 Midnight. After Midnight, rates for the next day are applicable.

NOTE 4 - When a truck larger than 26 feet is required, add \$5.00 to the vehicle and driver rates in all columns.
